Sewer

- 1. Bill Drew had a complaint from his tenant next door about the construction noise this was the second time he spoke to Bill. Yes there is noise next door at the WWTP, it is a major construction site. The noise is not constant or all day, the work must get done taking pictures will not get it done any faster.
- 2. The work in the WWTP is going along very well; the electrician has found many surprises in the wiring done. But it is being done correctly now.
- 3. We have had a construction meeting every week on Thursday since we started, usually Marge, Bud and I attend. It's great to see how all of the trades are working together to get the job done right and on time.

- 4. Marge has been working with a resident on Main Street about his sewer and water rates. Because of several changes in the classification of his property the rates were charged incorrectly part of the time. We feel it is now correct and we are waiting for him to sign and return the agreement that he has verbally agreed to (Dated 10/2/2012). This may be a good time to mention if you wish to change anything in reference to your property please do so in writing. Do not assume that the Town knows it and will just do it for you.
- 5. The Town tried to resolve another complaint that goes back to 2007. The State DOT will not come back 4 or 5 years later. I had their project engineer address every complaint we received approximately 5 before the left the job.
- 6. There was also a complaint about a job site on High Street, I had the contractor bring in more fill grade it off, seed and mulch it again. I hope this clears up that problem as well.
- 7. On October 26, 2012 we received the approval of our proposed 2013 WWTP budget from Tom Stalter.

Motion to approve a change order in the amount of \$15,190 for Vacri Corporation for the WWTP Project for the removal of the belt press made by Councilman Liddle, Seconded by Councilman Hall. All in favor, motion carried. Councilman Grommeck and Gladstone Absent.

1. WWTP Plant

• Plant effluent flows averaged 11,746 gallons per day for the month of October 2012.

2. SPDES Compliance/NYSDEC, NYCDEP

• The plant discharges of treated effluent to the Tremper Kill Brook; permit compliance for October 2012 did not meet all parameters due to the construction project. Effluent turbidity was >0.5 ntu for more than 2160 minutes for the month and was greater than 5.0 ntu due to a pipe fitting failure.

3. Collection System

- High Street is being maintained as required.
- On October 31st a manhole on Lower Main Street slightly overflowed due a blockage from gravel. Approximately 1050 feet of sewer main was jetted upstream and downstream to ensure the line was clear of debris.
