Parcels of land with a permanent dwelling are exempt from this requirement. Hyatt's also asked the procedure to build a barn on there property, Doug advises them to see Artie Short, the town building inspector. Doug will also look into the procedure for a special permit for camper and get information to Mr. & Mrs. Hyatt.

Next Merna Popper presented the board with pictures of flooding in her back yard on Main Street, Andes that she claims is caused by her neighbors fence. Merna feels the Zoning Board should do something to correct this problem. Merna claims the fence was banked by dirt for a flower garden and dirt is keeping water from draining so it pools into her yard. Doug advises Merna to go see Artie Short, Merna states she has been to see Artie and Artie told her to come to the ZBA. Doug said he will look into the matter but feels this is not a zoning issue but more of a civil issue between the two neighbors. Merna also asks what she needs to build onto her garage; again Doug told her she will have to see Artie Short for building permits and procedures.
