

On 6/17/2013 the State Office of Real Property Tax Services established a tentative 2013 State equalization rate of 100.00 for your municipality. This equalization rate was computed using data from your municipality's tentative assessment roll. If final assessment roll data produces a significantly different rate, we will recompute the equalization rate and notify you.

The Office of Real Property Tax Services applauds your efforts to comply with the statutory standard of assessment by completing a reassessment in 2013. The tentative equalization rate is the same as the "local stated level of assessment (LOA)" declared by the assessor and displayed on your tax bills. The tentative equalization rate indicates the level at which a municipality is assessing property in relation to its full market value, as measured by the Office of Real Property Tax Services. The tentative equalization rate clearly supports your LOA.

A written complaint and all evidence which you wish to submit in support of that complaint must be mailed or hand delivered to Darlene A. Maloney, Assistant to the State Board, at the Albany office of the State Board at the above address at least five days before the hearing date set forth above. The complaint must be made on the enclosed complaint form and signed by the chief executive officer or legal representative. Please refer to Subpart 8186-15 of the rules and the State Equalization Rate and Complaint Process booklet when preparing supporting documentation if you file a complaint. The complaint booklet is available on the Taxation and Finance website at http://www.tax.ny.gov/research/property/assess/rate\_doc.htm or you may contact your ORPTS regional office or Brian Moon or Kim Lee in Equalization Support Services in Albany at (518) 474-5666.

You will, however, have the opportunity to explain the written materials previously submitted, and/or to offer oral statements in support of your complaint. As the duly authorized representative of the State Board, the hearing officer will communicate your comments, in summary form, to the Board. Staff will review the written documentation you submitted in support of your complaint, to determine whether to recommend to the Board that changes be made in the calculation of the State equalization rate.

The State Board will meet on August 15, 2013 in Albany. We will notify you of the recommendation and the exact time and location of the Board meeting.

Dear Supervisor Donnelly:

As you may be aware, Governor Cuomo recently announced the availability of funding under the Community Redevelopment Zone (CRZ) Program. The Catskill Watershed Corporation (CWC) Board of Directors requested that all CWC member towns be informed of this program and funding opportunity.

Several watershed towns/villages are specifically named for funding of up to Three Million Dollars per zone for projects. Each zone must complete a community redevelopment zone plan. Once completed, each plan will recommend projects for funding from the CRZ Program. The Towns of Shandaken and Prattsville are eligible for up to Three Million Dollars each in funding. The Village of Margaretville and Village of Sidney are collectively eligible for up to Three Million Dollars. Finally, an Ulster County CRZ is collectively eligible for up to Three Million Dollars. At present, the draft Ulster County CRZ consists of the following communities: Town of New Paltz, Village of New Paltz, Town of Saugerties, Village of Saugerties, Town of Olive, Town of Woodstock, Town of Hardenburgh, and Town of Rosendale.

State representatives will be in touch with named towns/villages shortly to appoint representatives to the relevant CRZ Planning Committee. The State will provide, at no cost, consultants to assist the committee.

I personally recommend that you consider appointing an elected official, and that the appointments be done by board resolution. If your board appoints yourself or a board member, you can be kept up to date on the progress of the work of the Planning Committee.



All towns/villages, including those not named in the CRZ Program, may also apply directly for funding of eligible projects. More information on CRZ and other funding available can be found at <a href="https://www.sandyhelp.ny.gov">www.sandyhelp.ny.gov</a>. William Harding at the Watershed Protection and Partnership Program is our liaison to this program.

Re: DOL Prevailing Wage requirements

Under New York State Labor Law, contractors and subcontractors must pay the prevailing rate of wage and supplements (fringe benefits) to all workers under a <u>public work</u> contract. Employers must pay the prevailing wage rate set for the locality where the work is performed. Prevailing wage is the pay rate set by law for work on public work projects. This applies to all laborers, workers or mechanics employed under a <u>public work</u> contract. However, this provision does not apply when a project goes to a contractor who is doing all of the work himself or herself.

Please notice that the Labor Law specifies these wages for public works projects only. Private construction projects may contract for work under any wage, as long as it is at least minimum wage. The only time private work falls under the prevailing wage requirements is when it is being funded by a public entity (HUD, DEC, etc.

I hope this helps to clarify this question.
