- \*\* The advertising by way of signs and newspapers to alert dog owners that they must license their dogs was discussed and agreed upon.

### Supervisor's Report

- 1.) This morning, March 11, 2014 at 9:30AM we held a bid opening. The bids will be awarded this evening.
- 2.) On March 27, 2014 we will have a special meeting in reference to our proposed new courthouse at 7:00PM.
- 3.) On February 2<sup>nd</sup>, 2014 Tom Joyce met with the ACS Superintendent Dr. Chakar in reference to the Andes Pool and student lifeguards.
- 4.) We will have a proposed resolution tonight that will establish the Scenic Byway Management Entity.
- 5.) Andes resident David Capps would like to meet with me this month to discuss using Ballantine Park again this year for a dance program. I hope you will agree, it's only using a small section.
- 6.) Artie went to DEC Flood Plain Mapping Fundamentals class last week in Delhi on March 5, 2014.
- 7.) The transfer station decals program is working very well. We have only had one person that lives full time in NJ and part time here that does not wish to cooperate. His license plate has been turned over to the sheriff's office.
- 8.) Our neighboring Town of Middletown has had some problem with a local resident and a farmer and the manner he operates his farm. This would also apply to Forest land use. We have a local law on our books that gives all farmers the right to farm their land and when. I would like our town attorney to review it to make sure it does not need to be upgraded.
- 9.) The Central Catskill Mountain Collaborative is an advisory board to the NYS Route 28 Municipal Leaders Group as the board of directors for the scenic by way, Andes to Olive. Our members on the boards are Alex Adelson, Bud Gladstone, and myself. The formal agreement states that any director, a Supervisor or Mayor must receive approval by

resolution of their municipal boards to cast a vote on a particular issue. This does not allow the spending of Town funds on the By-way.

\*Supervisor Donnelly brought to the board's attention the lifeguard issue. The certification classes are \$270. It was discussed whether or not the town could reimburse the new lifeguards for their certifications, either partially or fully. Some of this money could come from the payments from South Kortright Central School to use the pool in the summer.

WHEREAS, the process toward the final approval of the Route 28 By-Way Plan by NYS can take anywhere from twenty-four to thirty-six months; and

WHEREAS, the process includes the establishment of a formal management entity for the By-Way; and

WHEREAS, there is no financial or other obligation attached to this step; and

WHEREAS, formalization of the management responsibilities during the final NYSDOT review and approval process will facilitate the process; and

WHEREAS, the Supervisors and Mayors in each of the following Towns and Villages along the proposed By-Way (Olive, Shandaken, Middletown, Fleischmanns, Margaretville, and Andes) have established the NYS Route 28 Municipal leaders Group comprised of the Supervisors and Mayors of each respective municipality;

THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Andes, Delaware County, New York, does hereby recognize the NYS Route 28 Municipal Leaders Group as the Board of Directors for the proposed Catskill Mountain Scenic By-Way under the following guidelines:

- 1.) The Board of Directors shall be comprised of the current Supervisor or Mayor of each municipality along the proposed By-Way as such:
  - a.) Town of Andes Supervisor
  - b.) Town of Middletown Supervisor
  - c.) Town of Olive Supervisor
  - d.) Town of Shandaken Supervisor
  - e.) Village of Fleischmanns Mayor
  - f.) Village of Margaretville Mayor
- 2.) The Board of Directors shall elect Officers (Chair, Vice-Chair and Secretary) annually or upon a vacancy created by election, resignation from elected office or death.
- 3.) If a vote/action is required by the Board of Directors, the members shall first receive approval through formal resolution by each of their respective municipal governing (Town/Village) Boards.
- 4.) If direct funding is requested/suggested from each municipality or from a specific municipality for a specific project, the municipality retains their right to approve or deny funding under Home Rule Statutes of New York State and each member must receive approval for any funding through formal resolution of their respective municipal governing (Town/Village) Boards.
- 5.) If any municipality denies the direct funding request, direct funding shall not be committed or required from that municipality.

BE IT FURTHER RESOLVED, the Town Board of Andes also recognizes that establishment of Central Catskill Mountain Collaborative as the Advisory Board to the Board of Directors for the proposed Catskill Mountain Scenic-By-Way under the following guidelines:

- 1.) The Advisory Board shall be comprised of two members of each municipality along the proposed By-Way as such:
  - a.) Each municipality shall appoint one municipal representative member from one of their existing formal municipal boards (Town, Planning, Zoning, Recreation, etc.).
  - b.) Each municipality shall appoint one at-large member (either a resident or business owner) who shall not be on any existing formal municipal board.
  - c.) Each municipality may elect to vote for one alternate member within any of the above criteria to act in the absence of either primary advisory member.
- 2.) Each municipality's advisory members shall be appointed or re-appointed annually by each of the following municipal governing boards: Town Board of Andes; Town Board of Middletown; Town Board of Olive; Town Board of Shandaken; Village Board of Fleischmanns; Village Board of Margaretville.
- 3.) The Advisory Board shall elect officers (Chair, Vice-Chair, Treasurer and Secretary) annually or upon a vacancy created by election, resignation or death. At no time shall one municipality maintain more than one member as an Officer on the Advisory Board.
- 4.) The Advisory Board members shall carry votes on the Advisory Board ONLY.
- 5.) The Advisory Board Chair, or designee, is required to attend the Board of Directors meetings to relay discussions within the Advisory Board.

NOW, THEREFORE, be it further resolved that the Town of Andes Board does re-affirm that the Central Catskill's Chamber of Commerce shall continue performing the duties of Interim Administrator as set forth in Board Resolution #9 of 2014.

WHEREAS, the proposed Local Law was on file for inspection at the Town Clerk's office prior to the hearing and during the review process;

NOW THEREFORE, BE IT RESOVLED AS FOLLOWS BY THE TOWN BOARD OF ANDES, DELAWARE COUNTY, NEW YORK:

### **LOCAL LAW #1 OF 2014**

### A LOCAL LAW TO INDEMNIFY OFFICERS AND EMPLOYEES OF THE TOWN

### Be It Enacted By the Town Board of the Town Of Andes:

<u>Section 1. Legislative Intent.</u> The Town herein enacts a local law to indemnify its Officers and Employees for actions taken when acting on behalf of the Town:

Title: Defense and Indemnification of Town Officers and Employees

### § 1-1 Definitions.

As used in this article, the following terms shall have the meanings indicated:

### **EMPLOYEE**

An employee of the Town of Andes.

### **OFFICER**

An officer of the Town of Andes, whether elected or appointed.

### SCOPE OF EMPLOYMENT

The performance of any act, duty or power in the furtherance of the interest of the Town of Andes by an officer or employee and which is related to the duties of such officer or employee.

### § 1-2 Assumption of liability for performance of duties.

The Town of Andes shall save harmless and indemnify any officer or employee of the Town from financial loss resulting from a claim filed in any court of competent jurisdiction for damages arising out of an act done or the failure to perform any act, provided that such officer or employee, at the time of the alleged act or failure to perform any act, was acting in the performance of his or her duties and within the scope of employment.

### § 1-3 Responsibility of officer or employee.

The officer or employee shall deliver, within 10 days of the time he or she is served with any summons, complaint, process, notice, demand or pleading, the original or a copy thereof to the Town Attorney and request the Town Attorney to assume control of his or her representation. The Town Attorney, upon receipt of any such summons, complaint, process, notice, demand or pleading, may assume control of the representation of the officer or employee. Upon assuming such control, the officer or employee shall cooperate fully with the Town Attorney.

### §1-4 Special or independent counsel.

A. At any time during the proceedings, if the Town Attorney feels that because of the nature of the claim, or the possibility of a conflict of interest between the officer or employee and the town, or for any other appropriate reason, that special or independent counsel should be retained, he or she may request the Town Board to appoint special or independent counsel to defend or assist in the defense of the officer or employee.

B. Upon such request, the Town Board may appoint such special or independent counsel as may be appropriate.

### § 1-5 Applicability to insurance policies.

This article shall not in any way impair, limit or modify the rights and obligations of any insurer under any policy of insurance.

### § 1-6 Rights of other parties not affected.

The benefits of  $\S 1-2$  of this article shall inure only to officers and employees of the town and shall not enlarge or diminish the rights of any other party.

### § 1-7 Applicability.

This article shall apply with respect to claims arising on or after the effective date of this article.

**Section 2. Effective Date**. This local law shall take effect immediately upon filing with the Secretary of State.
