- *Councilman Gladstone inquired whether or not a response had been received concerning when NYC planned to fix their roads. Supervisor Donnelly spoke with Wayne Reynolds at Delaware County and he indicated that it is very hard to get approval to do the work but they will work on it.
- *Councilman Gladstone requested Highway Superintendent McAdams to provide an estimate for hauling materials vs. having them hauled by a company.
- *Councilman Gladstone spoke about concerns over the new EPA Clean Water Act guidelines that are being discussed, which could lead to the need for permits just for cleaning ditches.
- *Councilman Hall inquired why the injectors on the 2009 single axle needed to be replaced already. McAdams stated that they were covered under warranty and the company did not say why they were bad already.
- *Supervisor Donnelly stated that Wayne Reynolds of Delaware County will be cleaning up in front of the highway garage, leveling, and planting grass seed.
- *On Tuesday, May 20, 2014 the streets in the hamlet will be swept. All cars must be off the street the night of May 19th. Thank you!!

Supervisor's Report

- 1.) I gave Kim the new debt repayment schedule on our water loan from the EFC #15916, a ten year extension and reduction in annual payments.
- 2.) The Supervisor of the Town of Deposit, Tom Axtell wrote to me on 3/13/14 in reference to a new upstate Towns association. This association is meant to replace the New York State Association of Towns. It might be a good idea for some or all of us to go to one of their meetings.
- 3.) On April 2, 2014 Marge received a request for more information in reference to our new \$75,000 grant from Senator Seward.
- 4.) On April 10, 2014 I wrote to Congressman Gibson in reference to FEMA. On May 8th, we met with two more guys that said they think they can now get us paid for the two outstanding PWs.
- 5.) On April 10, 2014 I wrote to Mr. Jeffrey Archer at the USDA, he was requesting that we purchase additional insurance for our loan on the highway garage as of today we have not heard from him.
- 6.) On April 10, 2014 I also wrote to Dubbens in reference to their service charges requesting that if they wished to continue working with the Town we would like you to send all invoices to Kim Tosi, Town Clerk.
- 7.) I would like to thank Councilman Joyce for all the hard work he volunteered for in September of 2013 during our budget process. He has worked very hard to try and be an extra hand for the Pool Directors Jackie and Rachel while they are working or in school. He has traveled back and forth to make sure we have enough lifeguards, he has tried to arrange the pumping out of the pool, and the balance will be pumped out just before it is cleaned. We considered hiring a pool company to clean out the pool but the directors want to do it. As of 5/7/14 we now have all our lifeguards that we need. We had hoped to get the pool open earlier in June but ACS would rather we didn't. The Town has agreed to pay a signing bonus, pay up to \$170.00 of the fee for the required certification, we have increase the hourly wages. In spite of comments made around town and on Facebook we do care about the pool. Some folks just can't get the message straight.
- 8.) On April 14, 2014 the NYS Office of Real Property Tax Services has confirmed our 2014 equalization rate at 100%.
- 9.) On April 23, 2014 NYS Department of Transportation wrote to Mike with our 2014 CHIPS reimbursement. **There was a \$31,000 increase given due to the hard winter we had.
- *Marge Merzig will be completing the CFA application for NYSERDA for the potential solar panels.

Committee Reports:

Pool- Councilman Joyce reported that next week the pool will be pumped again and the following week, the cleaning will begin. Artie Short and Joyce will be learning how to clean the pool and maintain the chemical levels for the future, in case the directors cannot be there. The Fire Department may be able to pump the water from the stream into the pool to fill it faster. Joyce also reported that there are now enough lifeguards for the summer.

Ballantine Park- Councilman Gladstone reported that Suzanne Gladstone has met with Peg Ellsworth of the MARK Project seeking a grant for the pavilion in the park.

Cell Towers- Councilman Joyce has reached out to AT&T and Verizon. They both indicate that they are checking out the area.

Other- Councilman Hall spoke in regards to the fantastic job being done at Bohlman Park and all of the other locations being cared for by Jon Andrews. Thank you Mr. Andrews for all of your hard work!

The enacted State fiscal year (SFY) 2014-15 Budget includes \$438.1 million in funding for municipalities to support the construction and repair of highways, bridges, highway-railroad crossings, and other facilities that are not on the State highway system under the Consolidated Local Street and Highway Improvement Program (CHIPS).

The Budget also includes a special one-time \$40 million capital allocation for extreme winter recovery to help local governments make necessary repairs to highways and bridges following this year's exceptionally harsh winter. These special extreme winter recovery funds complement the funding made available through the CHIPS Program and are available for use in SFY 2014-15. Please provide a copy of this letter to the chief financial officer (CFO) for your municipality.

The SFY 2014-15 CHIPS and the special one-time \$40 million extreme winter recovery appropriation reimbursements are scheduled to be made on June 16, 2014. Please refer to the April 2014 CHIPS Guidelines and April 2014 \$40 million appropriation Guidelines on the CHIPS website (www.dot.ny.gov/programs/chips) regarding eligible project activities and program requirements.

Instructions to apply for the CHIPS funds for the June payment are on the reverse, while instructions to apply for the special one-time \$40 million extreme winter recovery appropriation are included as a separate enclosure. CHIPS and the \$40 million extreme winter recovery appropriation project information will be collected via the April 2013 CHIPS and April 2014 new \$40 million extreme winter recovery appropriation on-line fillable reimbursement request forms which are available on the CHIPS website. Requests for both appropriations from the SFY 14-15 apportionments for the June payments must be for expenditures made on or after April 1, 2014 and through May 8, 2014.

The Town of Andes has a total CHIPS balance of \$467,552.09 which is available for the June payment; this consists of a \$265,546.30 SFY 14-15 CHIPS apportionment balance and a \$202,005.79 CHIPS Capital cumulative rollover balance. The Town of Andes has a total new \$40 million extreme winter recovery appropriation balance of \$31,491.76 which is also available for the June payment.

The Town of Andes must ensure the NYSDOT Regional Office receives the reimbursement requests from each of these appropriations no later than May 14, 2014 to receive these payments. The submissions for CHIPS and the new \$40 million extreme winter recovery appropriation will require supporting documentation (copies of checks, invoices, etc.) also be provided. Please be sure to sign the certification on each page of the reimbursement request forms, photocopy the completed forms for your files, and mail the originals to:

Dear Supervisor Donnelly,

Over the last six - eight months the control panel, located at the water filtration plant, has been periodically malfunctioning the cause of which is unknown however we expect fatigue caused by thunderstorms (low or surge voltage). These faults have increased and it is becoming evident a failure is imminent.

Failure of the system could potentially lead to a health code violation. We therefore are recommending the replacement of the control panel be declared an emergency, and the repairs begin as soon as possible. We received a quote from Turnkey Control Solutions, Inc. (TCSI) to replace the current system with a more robust unit. The cost will be approximately \$16,000.

Additionally we have requested, from TCSI, a quote for surge protection at both the water and wastewater facilities. We anticipate this quote within the next two weeks.

Per your request TCSI is pleased to offer the following Proposal for your WTP Upgrade project. This proposal is for labor and materials, including travel expenses to Andes WTP in Andes, NY. The new control system will control two booster pumps, two fire flow pumps, three electrically actuated valves, two UV disinfection units, and provide alarming and remote access over the phone line. One 12" panel mounted touch screen HMI will be provided with limited monitoring functionality. This project will include the modification of the existing panel to allow for PLC controls.

1) TCSI will provide the following materials & services:

- Modification of one 24"x30" Pump Control Panel with the following door mounted devices: 4 hour meters, 4 pump HOA, 3 valve HOA and one general alarm light
- New 12" panel mounted touch screen HMI
- Allen Bradley processor and I/O
- Ethernet switch & four motor starters: contactors with overload relays
- All control terminations in the PCP cabinet only.
- Develop new graphic screens for all necessary control and monitoring including pump alternating selection; alarm screen; pump, valve, & UV status; pump & valve start/open overrides
- Develop new PLC logic
- Verify wiring from field devise to HMI.
- Test & tune controls
- PCP control wiring drawings in AutoCAD 2000 format.

2) Sequence of Operation

- All pumps can be started from the PCP using the HOA selector switches in the hand position
- All three valves can be opened or closed from the PCP using the HOAs
- The HMI will have multiple display screens in which to monitor and control the system. All pump status, HOA switch status, valve position status, alarm status, tank level and UV status will be displayed.
- If the pumps or valve HOA switches are in the Off position they will not start and can not be started remotely.
- In the Auto position both fire flow pumps will run simultaneously. The PLC will receive a signal from the LLC calling the pumps to start. The PLC will call for the 4" valve to open, once it is confirmed open the pumps will start.
- The PLC will receive a signal (first float) from the LLC to initial the start sequence for the first UV unit to start. The PLC will send the request for the UV to start and wait approximately 3 minutes before opening the 3" valve and starting the booster pump
- The second UV/booster pump system will start on a signal from the second float switch.
- The UV systems will automatically alternate daily. A soft selector switch and indication will be on the HMI panel
- If the first UV system fails to start an alarm will be triggered and the second unit will start.
- If the any device is called to be open/on and the PLC does not receive an indication that it has completed the request a fault alarm will be triggered.
- Any alarm will be indicated by a red lamp on the control panel
- All alarms will be displayed on the HMI Alarm screen

Alarms will include as a minimum Effluent Turbidity High, UV #1 failure, UV #2 failure, Low water level
in Chlorine contact tank, fire flow pump active, general pump failure, Gladstone Hollow pump failure,
Chlorine pump failure, & power failure
