**RES. #37 \_\_\_\_\_ New Highway Garage Project SEQR Resolution**

WHEREAS, the Town Board of the Town of Andes is undertaking a New Highway Garage Project (hereinafter referred to as "the Project") to provide improved highway facilities in the Town of Andes; and

WHEREAS, the project includes construction of new highway garage and appurtenances and other improvements as needed in the general vicinity of the highway storage site on County Highway 1, known as the Tremper Kill Road; and

WHEREAS, the Town of Andes is securing funding for the new facility;

NOW, THEREFORE BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF ANDES AS FOLLOWS:

1. The Town Board intends to proceed with the Engineering and Design of the New Highway Garage to provide improved highway facilities in the Town of Andes; and
2. The Town Board hereby authorizes the Supervisor to execute a professional services agreement with Delaware Engineering, P.C.; and
3. The Town Board intends to comply with City, State and Federal environmental regulations; and
4. The Town Board hereby determines that the project is an Unlisted Action pursuant to the State Environmental Quality Review Act (SEQRA), Article 8 of the New York Environmental Conservation law and its implementing regulations, 6 NYCRR Part 617; and
5. The Town Board hereby instructs the Supervisor, with the assistance of the consulting engineer, to prepare a Full Environmental Assessment Form (FEAF), notify involved agencies of the Town Board's intent to serve as SEQRA lead agency and to further initiate the Coordinated Review of the Project under the SEQRA regulations; and
6. The Town Board hereby declares itself as SEQRA Lead Agency, provided that no involved agency objects within 30 days of the date of that the FEAF was submitted to them; and
7. The Town Board hereby authorizes the Supervisor to sign all environmental review and funding documents for the Project on their behalf. <sup>2</sup>
8. The Town Board hereby schedules a public scoping session and public hearing on the SEQR review for 12:30 pm Tuesday, March 11 at the Town Hall.

2004 Int 4X4 – Changed oil and greased, checked all fluids and changed wing blade. 25,180 miles

2000 Int – changed oil and greased, checked fluids, replaced dip stick tube & dip stick, fixed front of wing and installed new wing bolts. 131,140 miles

1999 Int – Checked all fluids and greased, fixed lights, and wing, replaced leaking air line and valve. 147,970 miles

1991 Autocar 4X4 – Sent transfer case away, installed all new u-joints, in process of draining and tearing apart rear end to fix. 54,315 miles

2000 F550 – Replaced brake line, rewelded plow braces, installed new studs and rim on passenger side rear. 55,760 miles

2003 JD Loader – Changed oil, fuel filters, greased. 3568 HRS

1989 JD Grader – Changed oil, fuel, air, hydraulic, transmission filters, Greased and installed new front windshield

D.C.A.S. Refuse & Trucking Inc has given me a quote for \$50.00 a month for use of a garbage container. Because of our schedule we don't always have time to go to the dump and this would be very useful.

**WHEREAS**, New York State Route 28 is the major thoroughfare of the Central Catskill Mountains, offering the traveler a unique experience of mountain scenery and clear waterways, complemented by historic hamlets – and it is this combination of resources that gives the region much of its scenic and community character and is vital to the region's economy; and

**WHEREAS**, Route 28 passes through the heart of the Catskill Park, a resource created by an act of the State Legislature in 1904 and now encompasses approximately 700,000 acres, about half of which are lands of the Forest Preserve and held in the public trust; and

**WHEREAS**, Much of the land in the Central Catskills lies in the New York City Watershed and provides unfiltered drinking water to some 9 million New Yorkers and the historic Memorandum of Agreement has enabled a series of partnership programs to further the mutual goals of watershed protection and environmentally sensitive economic development; and

**WHEREAS**, The State of New York recognizes the importance of local governments and has committed to providing \$500,000 for a Central Catskill Mountain Smart Growth Program to support improvement projects that retain the vibrancy of the hamlets, villages and town centers along the Route 28 Corridor, specifically in the Towns of Andes, Middletown, Olive and Shandaken, and the Villages of Fleischmanns and Margaretville; and

**WHEREAS**, These six Central Catskills municipalities share many of the regions unique resources and can mutually benefit by exploring cooperative approaches, engaging in intermunicipal discussions and identifying collective strategies and actions that support and enhance such shared resources; and

**WHEREAS**, Numerous studies, reports and conferences have focused on the Central Catskills and encouraged and promoted intermunicipal and regional planning, marketing and development; and further, these efforts have put forth numerous recommendations which have not been fully realized; now therefore be it

**RESOLVED** In the spirit of cooperation, we the undersigned commit to working with the Central Catskills Collaborative (or other mutually determined name) through a locally based process that builds on local goals and objectives and engages in a regional dialogue focused on protecting and promoting the scenic, cultural, historic and economic well-being of the Route 28 Corridor and the Central Catskills; and be it further

**RESOLVED** the signatories understand the Collaborative may conduct such activities, including, but not limited to, identifying and pursuing specific actions to provide better access to natural and cultural resources; exploring design guidelines, signage coordination and incentives to preserve scenic character; utilizing joint marketing approaches and funding mechanisms to support and encourage qualified economic development; and incorporating advisory members, including individuals with related interests and representatives from groups such as chambers of commerce, public agencies, not-for-profit organizations, other local governments and private stakeholders; and be it further

**RESOLVED** The signatories understand that passage of this resolution does not bind the undersigned municipalities in any way other than the above stated commitment; and be it further

## TOWN OF ANDES, NY TOWN BOARD MEETING REPORT BY DELAWARE OPERATIONS February 12, 2008

### 1. Water System

- Daily usage of treated water from the water system averaged 16,100 gallons per day for the month of January 2008.

### 2. Plant Purchases

#### 1. WWTP Plant

- Plant effluent flows averaged 38,300 gallons per day for the month of January 2008.

#### 2. SPDES Compliance/NYSDEC, NYCDEP

- The plant discharges of treated effluent to the Tremper Kill Brook; permit compliance for January 2008 met all parameters.

#### 3. Collection System

- High Street is being maintained as required.
- Delaware Operations request the approval for Northeast Pipeworks to clean and TV approximately 1770' of sewer line at a cost of \$1.35 a lineal foot plus a \$500.00 mobilization fee. The WWTP is experiencing very high inflows, more than the water system is producing by a factor of almost 3X.

#### 4. Plant Purchases

- Delaware Operations request the purchase of a new TB Woods VFD to run press sludge pump #2, the existing VFD failed. The local distributor Kaman Industrial Technologies shall supply 1 10 horse TB Woods VFD for the sum not to exceed \$1457.15 plus shipping costs. The cost to repair the existing VFD is \$1600. We requested that an evaluation be done on the existing VFD to determine the cause of the failure at a cost of \$250.
