- *McAdams reported that he is receiving applications at this time to fill the vacant positions.
- *McAdams asked the board to address and potentially adopt a policy regarding the replacement of driveway pipes. Many individuals in town are living on a fixed income and cannot afford to replace their pipes. This is causing damage to the town roads. McAdams will be talking to Delaware County to find out their policy on the issue.
- *Supervisor Gladstone asked McAdams if he could find out how much time town has saved this winter, not having to buy sand and on overtime.
- *Councilman Hall asked what happened to the chipper. The pump wouldn't stay fastened and this needed to be corrected.

Supervisor's Report

- *2/10-I met with Tom Suazzo regarding the well sites and contract. Looked at possible sites at the Rural Cemetery property on High Street. I have also been in contact with the new owners of the former Ruff farm behind the Catholic Church about possibly that well. I will be having further discussions with them regarding this.
- *Received a letter from the Andes Seniors Group thanking the board for our support. We also received a donation from Lloyd and Sally Johns for Ballantine Park.
- *2/18 Kim sent me a notice that we need election inspectors for the Democrat Party. Anyone interested should contact the Delaware County Board of Elections (607) 832-5321.
- *2/27 I attended a meeting in Arkville for the Catskill Center for Conservation and Development. The focus was better access to our region for recreation and activities.
- *3/4- The Flood Commission had their walk thru of the stream through the hamlet.

*3/5- I attended a meeting in Boiceville for a group trying to get train tracks from Kingston to Arkville to help give people a new way to experience our area.

*3/7- I met with Ann Roberti, Alex Adelson, Marty Donnelly, and Tom Joyce regarding the railroad station to discuss what types of use will be allowed.

*3/8- I had a couple phone discussions with a gentleman by the name of Alex Wilson from "Way Side Cider" who is interested in buying the former Decker property on Redden Lane for his cider production business.

*Thank you to Willow Drey Farm for the food bank fundraiser they held on February 20th. It was very successful.

*Councilman Joyce had a request from Dorothy McArdle regarding the sale and potential water connection for the old Decker Building currently owned by Bill Day. The Town does not have any authority over the situation. It is a private property matter. The potential buyer will have to contact George Redden and Bill Day.

Committees:

Flood Commission-

Councilman Joyce discussed the walk-through. There will be a public hearing in the near future.

Pool-

Councilman Joyce reported that he has met with Rachel Andrews and she will be coming back this summer. She is now a lifeguard instructor and can teach and re-certify our lifeguards. This will be a great savings to the Town. All lifeguards will need a raise this year. Rachel brought Joyce a list of things the pool needs.

The kiddie pool needs to be hooked up to the main pool. The parts will be ordered with Delaware Operations. The storage shed needs a new roof, floor, and ramp. Councilman Hall suggested that purchasing a new building may be cheaper from a place like the Amish Barn Co. This will be evaluated. The chairs need to be replaced. The bathrooms have a mold problem. There is no ventilation. This may be solved by dehumidifiers. The sidewalk also needs to be fixed where it was dug up and in another spot on the other side of the pool where some settling has made a dangerous lip.

It is hopeful that the pool will be open the week of June 27th but no later than July 1st.

Construction-

Supervisor Gladstone reported that there is currently some construction going on at the library.

Economic Development-

Councilman Joyce reported on the March meeting. The brochure and Community Weekend were discussed. Joyce will be working with Marge Merzig on some potential funding for the brochure.

RR Station-

The railroad station construction is almost complete.



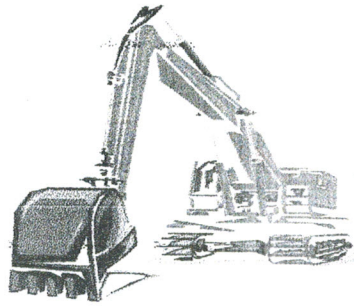
