Call to Order:

The meeting was called to order at 7PM by Supervisor Gladstone.

Pledge:

The pledge of allegiance was led and recited by Councilman Moshier.

Moment of Silence:

A moment of silence was held for Millie Johns, a longtime resident of the Town of Andes, teacher at Andes Central School, and former Mayor of the Village of Andes.

Approval of Minutes:

Motion to approve the May Regular Meeting Minutes and May Special Meeting Minutes, made by Councilman Joyce, Seconded by Councilman Moshier. All in favor, Councilman Hall-absent and excused, motion carried.

Privilege of the Floor:

*Frank Perkins

RE: Gulf Brook Road

Mr. Perkins voiced his concern regarding Gulf Brook Road. He stated that after the 2006 and 2007 floods, the residence were very lucky to have a new bridge installed. However since then it seems that it takes years for any kind of work to be done. The ditch is getting washed away and he is afraid if it does not get fixed that it will keep eroding. He also voiced concern over the Town website. The Town is not addressing issues as they should be. Supervisor Gladstone offered to set up a time with the highway superintendent and Mr. Perkins to go over his concerns.

*Thad Hust and Ron Manwaring- Monroe Tractor

RE: Loader Trade In

Mr. Hust and Mr. Manwaring came before the board regarding the trade in of the town's current loader subsequent to the bids for the new loader and its purchase. They presented a sealed bid with the trade in value enclosed. The only other bidder, Five Star Equipment, included a trade in value in their original bid. Supervisor Gladstone opened the sealed bid from Monroe Tractor. These bids are attached.

Discussion over the bids took place. Chris Olds spoke on behalf of Five Start Equipment. Mike Terry, a highway employee, requested that they be able to test the machines, prior to the board's decision. Both companies agreed that could be arranged. Supervisor Gladstone advised that the Town will be speaking with their attorney to make sure all appropriate procedures are being followed and a special meeting made be called in the following weeks.

Reports:

Highway Report (Attached)

*The chipper is running.

*Supervisor Gladstone brought up the purchase of a roller. He stated that he believes the Town cannot afford a new roller and should look at used machines. This will be discussed again at the next meeting

Supervisor's Report

*May 29th- I was notified of a safety concern at the transfer station. Temporary repairs were performed. We need to discuss permanent solutions for safety and efficiency with the station. -The bathroom at the Railroad Station is almost done. After that is complete we will be putting in the new driveway.

June 6th- I contacted Senator Seward's office regarding the possibility of getting safety/warning lights for the school crossing. I also asked about grant funds to do the foot bridge across the Tremperskill from Ballantine Park to the Railroad Station. We asked for \$150,000.

June 10th- I received notification of an award of approximately \$53,000 for stream repair on Close Hollow Road.

- *Next week we will be doing tests on the new well and library well to try and solve sulfur problems.
- *A letter of resignation was received from John Gregg, a member of the Flood Commission. He was the member representing the ZBA. A member of the ZBA should be asked to replace him.

Committees:

Economic Development-

Supervisor Gladstone introduced Robyn Ciccone the newly elected Chamber of Commerce President. The Economic Development Committee will continue to meet on the first Monday of the month at 6PM at the Andes Hotel. The Chamber of Commerce will take over the meetings following Community Days.

Flood Commission-

On July 6th, the Flood Commission along with Barton and Loguidice will be performing a walkthrough of the hamlet with the property owners. At the most recent meeting the consultants

presented their developed plan for mitigation. After the walkthrough there will be another public meeting at the school. One of the proposed projects will be to move the tennis courts at the school to create a flood plain. Councilman Moshier stated that would upset a lot of people. Councilman Joyce stated that all projects have to be 100% agreed upon by the landowners. If they do not agree then nothing can be done. No one will be forced to do anything.

Pool-

Councilman Joyce reported that the pool has been drained and is now being filled. It should be filled by Friday. Then we will be using a 'waste' pump to try and removed the rest of the debris from the pool. Rachel will be working on finishing her opening procedures. She will not be able to be in the pool for a month after her operation however she will still be able to do the schedules and teach lessons, etc. There is a panel on the fence that needs to be replaced. Artie still needs to install the fans in the locker rooms as well as paint them. He has been asked to do this b the end of the week.

Transfer Station-

Supervisor Gladstone reported that there was an issue with the C&D platform and we were able to get Dale Kirby to provide a temporary fix to make it safe. Something more substantial will have to be done in the future. He suggested that they recreate the area, allowing Delaware County trucks to have easier access, putting the C&C, metal, and cans all in a row. Councilman Moshier suggested that the platform be rebuilt with material other than wood.

Residents have been requesting that homes that are used as Air BnB rentals be allowed to utilize a transfer station sticker as a residence instead of for a car specifically. Then the renters would be able to use the transfer station as well. This topic will be discussed further at the next board meeting.

Railroad Station-

Councilman Cole brought up the visibility of the drivers coming out of the proposed driveway at the Railroad Station. He suggested that maybe the Town should install a blind driveway sign or a flashing lights. Supervisor Gladstone stated that he would speak with Wayne Reynolds at Delaware County regarding the situation and see if he has any suggestions.

Cemeteries-

Councilman Moshier reported that the team from Delaware County will be out in the next several weeks to fill in sinking graves and fix stones. We will receive a bill from them which will be paid by the Cemetery. The fencing that needs to be installed at the Shavertown Cemetery was also discussed.
