Dear Mike:

In response to your March 25, 2009 comment letter and our March 30 telephone conversation, we have enclosed for your review and approval one complete set of contract drawings (with revisions of indicated sheets) and excerpts of revised specifications which address your comments.

We believe that we have addressed all of your comments and believe that the plans and specifications are now ready for USDA approval.

We have addressed your March 25, 2009 letter comments as follows:

## Comment #1

The Preliminary Engineering (Architectural) Report is acceptable as submitted.

## Response:

We understand that the PER is a separate document from the plans and specifications, and that the PER has been deemed to be acceptable as submitted. USDA approval of the plans and specifications is needed before the project can proceed to bidding and this submission will facilitate that approval.

## Comment #2

Seismic Certification and Engineer's Certification is needed on the title page. (see attached)

## Response:

We will add both certifications (as set forth on the attachment to your March 25<sup>th</sup> letter) to the cover of the drawings.

## 242 Comment #3

RD front end items, forms, etc., are needed in the specifications/project manual (see attached).

## Response:

We have included all necessary RD front end items, forms, etc in the specifications.

## Comment #4

Parking was not included on the drawings, particularly an accessible space, access aisle and signage.

## Response:

We have revised drawing sheets G-2 and G-3 to add a handicapped accessible parking space and adjacent aisle and signage details. Paving has been extended around the northeast end of the building, on the side of the building near the office, to provide a suitable surface for wheelchair travel from the space and aisle to the front of the building.

## Comment #5

Lever handle hardware is needed on doors.

## Response:

All interior doors currently have levers. We understand that USDA requires lever handled hardware to allow for access by disabled persons. All interior doors currently have lever handled hardware. Exterior door hardware have been changed to provide for level handles.

The hardware schedule has been changed on Sheet G-3 and in technical specification Section 08100 - Hollow Metal Doors.

## Comment #6

Ensure the required latch side clearance on the pull side of the doors (minimum 18"/24" preferred) and on the push side of the door (minimum 12") when the door has a latch and a closer. There are conflicts with these doors:

## Response:

We understand that your concern is to provide adequate clearance particularly on door pulls in relation to adjacent items (e.q., bookcases, file cabinets, etc.). We have revised drawing Sheet G-3 to relocate bookcases and file cabinets in the office and break room which could be less then 24 inches away from the door pull.

## Comment #7

The accessible toilet stall in the men's room appears to be non-compliant.

## Response:

The toilet stall in the men's room is 60" x 60" which complies with the standard for handicapped accessibility (56" x 60"). We have added dimensions to drawing Sheet G-3 to demonstrate compliance.

## Comment #8

Preconstruction conference and payment application meetings and inspections need to be coordinated with the RD Construction Inspector.

## Response:

We understand and will coordinate as required with the RD Construction Inspector.

Dear Commissioners Burdick and Campbell,

You are to be commended for your diligence on behalf of the residents and taxpayers of Delaware County. However, it is with deep concern that I write to you concerning the proposed closing of the Town of Andes District #2 polling site. This site has served the residents/voters on the backside of the Pepacton Reservoir for many, many years. This area serves many of the Town's senior citizens who, I am sure you know, never miss the opportunity to cast their vote. With this proposed change we will be discouraging their act of good citizenship. At a time when our country in general faces a voter turndown, we must encourage the benefit that so many Americans have had to die to give us, not create an obstacle to voting.

I have discussed this subject with Commissioner Campbell a number of times; Andes has almost always exceeded the county voting turnout. Now let me apologize; it is indeed unfortunate that the Board of Elections had to deal with a representative of the Rod & Gun Club, instead of the Town Board or Supervisor of Andes. Upon hearing of his remarks to you, the members of the Rod & Gun Club held a special meeting and voted him out of office. They have requested that you reconsider your decision and continue the polling site at their location. A copy of their letter is enclosed.

In reference to either Delhi or Walton, neither one of those towns is divided by the Reservoir. Driving around the Pepacton in November or March, in fact from the first to the last snow, can be very dangerous as the records will show, as well as dealing with 5 floods in the last four years which caused roads to be closed. We do appreciate your willingness to consider a second site below the reservoir, but we believe this would be difficult since it is very rural and residential and every other public building that existed is under the reservoir waters. It would be far more expensive to the County to obtain a parcel of land and then to erect and maintain a satisfactory building to house a polling site, much more expensive than another voting machine. We have not even touched on the fact that N.Y.C. pays to the county substantial tax dollars that are shared by all of the member towns in Delaware County. The Pepacton creates a hardship only for those residents who beyond it, not for the entire county - don't make it worse!

The Rod & Gun Club has reversed all of the negative comments made to you and reported in your letter of March 26, 2009. In closing I ask you to please reconsider your decision to close the District #2 polling site in view of the facts and of the hardships this closing will create. Thank you. FILE

## **Smoke-free Movies Resolution**

248

Whereas tobacco use is the leading cause of preventable death and disability in the United States;

Whereas each year an estimated 390,000 teens start smoking because of their exposure to smoking in movies, 120,000 of whom will die prematurely as a result;

Whereas the tobacco industry has a long, documented history of promoting the use of tobacco and particular brands on screen, while concealing and denying the practice;

Whereas the U.S. Centers for Disease Control in 2002, 2003, and 2005 listed smoking in movies as a primary reason that the decline in teen smoking has stalled;

Whereas the World Health Organization ,American Medical Association American Medical Association Alliance ,American Academy of Pediatrics ,American Legacy Foundation ,American Heart Association ,American Academy of Allergy, Asthma, and Immunology Americans for Nonsmokers Rights ,California School Nurses Association ,Center for Tobacco Free Kids ,Society for Adolescent Medicine and many other organizations- endorse getting smoking out of future movies rated G, PG, and PG-13

Whereas the majority of state Attorneys General have written the Motion Picture Association of America urging Hollywood to play and active role in reducing the number of children who smoke because of smoking in the movies; and endorsing the four simple voluntary goals of the smoke free movies initiative.

## Rate New Smoking Movies R

Any film that shows or implies tobacco should be rated R. The only exceptions should be when the presentation of tobacco clearly and unambiguously reflects the dangers and consequences of tobacco use or is necessary to represent smoking of a real historical figure;

## Certify No Pay-Offs

The producers should post a certificate in the credits at the end of the movie declaring that nobody on the production received anything of value (cash money, free cigarettes or other gifts, free publicity, interest-free loans or any thing else) from anyone in exchange for using or displaying tobacco;

## Require Strong Anti-Smoking Ads

Studios and theaters should require a genuinely strong anti-smoking ad (not one produced by a tobacco company) to run before any film with any tobacco presence, regardless of its MPAA rating;

## **Stop Identifying Tobacco Brands**

There should be no tobacco brand identification or the presence of tobacco brand imagery (such as billboards) in the background of any movie scene;

- Section 1. The filing of an application by the Town of Andes for Small Cities CDBG funds in the amount of \$400,000.00 and the same is HEREBY approved.

• The plant discharges of treated effluent to the Tremper Kill Brook; permit compliance for March 2009 met all parameters.

## 4. Plant Purchases.

- Delaware Operations requests the approval to purchase two Keller level transducers from Aqua-Aerobic Systems, Inc at a cost not to exceed \$1,290.00 plus shipping. In the past month two level sensors have gone bad on in the digester, which can be controller manually without much difficultly and the other in the SBR B, which is critical in the operation of the SBR's.
- Delaware Operations requests the approval to purchase 12 sub modules for the Micro filtration units from Siemens Water Technologies at a cost not to exceed \$28,800 plus shipping at a cost not to exceed \$780.00. The new modules are needed to decrease the operating pressure of the units. As the modules age some fibers break, which need to be plugged to maintain operating pressures. This issue has been compounded by the lack of an automatic backwashing strainer before the Mico filtration units that was omitted in the original plant design.
- Delaware Operations requests the approval to purchase piping from McMaster-Carr to use for bypassing the micro filters if a failure occurs before an upgrade happens. The cost shall not to exceed \$1,139.69 plus shipping. This piping will still allow the use of the sand filters as where the original design of the plant does not.

 Delaware Operations request the approval for HACH Company's yearly PM contract to service and calibrate five turbidity meters at a cost not to exceed \$937.00.
