# RES. #39 TITLE: ADOPTION OF THE EAST AND WEST BRANCH DELAWARE RIVER STREAM CORRIDOR MANAGEMENT PLANS

WHEREAS, The Delaware County Soil and Water Conservation District (DCSWCD) and New York City Department of Environmental Protection (NYCDEP) have worked closely with a local Project Advisory Committee, the Town of Andes and other watershed stakeholders to develop the East Branch Delaware River (EBDR) and West Branch Delaware River (WBDR) Stream Corridor Management Plans (SCMPs) which takes a science based, long term management approach to the streams in the basin; and

WHEREAS, The Delaware County Board of Supervisors declared lead agency for the adoption of both SCMPs and coordinated the environmental review with the other involved agencies, towns, and villages as a Type 1 action under 6 NYCRR Part 617 of the State Environmental Quality Review Act (SEQRA); and

WHEREAS, Delaware County Board of Supervisors issued a negative declaration under SEQRA for the adoption of the EBDR and WBDR SCMPs, Resolution No. 206, on October 22<sup>nd</sup>, 2008; and

**WHEREAS,** the Delaware County Board of Supervisors have adopted the EBDR and WBDR SCMPs by Resolution No. 207, on October 22<sup>nd</sup>, 2008; and

WHEREAS, The EBDR and WBDR SCMPs address water quality and economic vitality issues as defined by local communities and regional experts; and

WHEREAS, The Town of Andes has adopted and supports the goals of the Delaware County Action Plan for water resource protection; and

**WHEREAS,** The Town of Andes has adopted and supports the goals of the Delaware County All-Hazards Mitigation Plan; and

WHEREAS, The DCSWCD and the Town of Andes recognize that the EBDR and its tributaries are a key element of the identity of the Pepacton Reservoir watershed, and the WBDR and its tributaries are a key element of the identity of the Cannonsville Reservoir watershed; and

WHEREAS, The DCSWCD and the Town of Andes have worked cooperatively on stream management issues relevant to both public and private interests; and

WHEREAS, The DCSWCD and the Town of Andes desire to work cooperatively to implement the EBDR and WBDR SCMPs for the common benefit of both parties, protection of the natural resources and the interests of the broader watershed stakeholders;

NOW, THEREFORE, BE IT RESOLVED The Town of Andes recognizes, and adopts the East and West Branch Delaware River Stream Corridor Management Plans as guidance documents that can assist the Town and its landowners with addressing long term management of the East and West Branch watersheds in a manner that is consistent with the protection of public and private property, the protection of natural resources, goals and strategies for water quality protection, and economic opportunities as defined in the plan, and in a way that will provide the Town of Andes, its landowners and visitors with multiple benefits.

# AMENDMENT TO AGREEMENT BETWEEN THE CATSKILL WATERSHED CORPORATION AND TOWN OF ANDES FOR INSTALLATION OF STREAM CORRIDOR PROTECTION MEASURES

THIS AGREEMENT, made and entered into the \( \frac{\psi}{2} \) day of \( \frac{\pi\_2}{2} \). 2010, by and between THE CATSKILL WATERSHED CORPORATION (the "CWC"), a local development corporation having its principal office at Main Street, P.O. Box 569, Margaretville, State of New York, and the TOWN OF ANDES ("the Owner"), located at 580 Main Street, Andes, County of Delaware, State of New York, the CWC and the Town of Andes collectively referred to as the "Parties"; and

WHEREAS, the CWC is a non-profit corporation established to administer Watershed Protection and Partnership Programs, including the Stream Corridor Protection Program ("Program"); and

WHEREAS, pursuant to the 1997 New York City Watershed Memorandum of Agreement (Watershed MOA), paragraph 127, New York City Department of Environmental Protection (NYCDEP) established a Stream Corridor Protection Program to pay for the costs of designing, constructing and implementing stream corridor project projects in the West of Hudson Watershed such as stream bank and channel stabilizations; and

WHEREAS, pursuant to Paragraph 127(d) of the 1997 New York City Watershed Memorandum of Agreement (Watershed MOA), CWC transferred funds and shall select and design the projects and allocate amounts of such CWC Stream Corridor Funds to each selected project jointly with New York City and in consultation with municipalities; and

WHEREAS, the Town of Andes applied for grant funding as described in the Stream Corridor Protection Program application and the Gladstone Hollow Culvert Replacement Project has been reviewed by the Board and been determined to be an eligible project for funding; and

WHEREAS, pursuant to Resolution Number 1389, the CWC Board approved funding to the Town of Andes and authorized a not to exceed amount of One Hundred Thousand Dollars (\$100,000) for design, construction and implementing a Stream Corridor Protection Project with regard to the Gladstone Hollow Culvert Replacement Project as described in their program application; and

WHEREAS, pursuant to Resolution Number 1548, the CWC Board approved additional funding to the Town of Andes and authorized a not to exceed amount of One Hundred Twenty-Seven Thousand Dollars (\$127,000) for design, construction and implementing a Stream Corridor Protection Project with regard to the Gladstone Hollow Culvert Replacement Project; and

WHEREAS, pursuant to Resolution Number 1625, the CWC Board approved additional funding to the Town of Andes and authorized a not to exceed amount of One Hundred Forty-Four Thousand Dollars (\$144,000) for design, construction and implementing a Stream Corridor Protection Project with regard to the Gladstone Hollow Culvert Replacement Project; and

WHEREAS, the Town of Andes has applied for additional funding in the amount of Two Thousand Five Hundred Dollars (\$2,500) as described in the revised budget for the Gladstone

Hollow Culvert Replacement Project and has been reviewed by the Board and been determined to be an eligible project for additional funding; and

WHEREAS, pursuant to Resolution Number 1814, the CWC Board approved additional funding to the Town of Andes and authorized a not to exceed amount of One Hundred Forty-Six Thousand Five Hundred Dollars (\$146,500) for construction and implementing a Stream Corridor Protection Project with regard to the Gladstone Hollow Culvert Replacement Project as described in their program application; and

NOW THEREFORE, the Parties Agree and Stipulate that the Agreement originally dated \* Treptember 25, 2008 between CWC and the Town of Andes is amended as follows:

# Section 3.02 Payment Generally

As The CWC shall pay the Owner or the Owner and Contractors in an amount not to exceed One
Hundred Forty-Six Thousand Five Hundred Dollars (\$146,500) over the term of this
Agreement for the eligible Stream Corridor Protection Costs associated with designing
and/or implementing the Stream Corridor Protection Project incurred during the term of this
Agreement, in accordance with the payment procedures set forth in Section 3.03 of the
Agreement. CWC may decrease the recommended funding limit after receipt of construction
bids, CWC shall withhold the 10% contract retainage on construction costs as outlined above in Section 2.01.

11 IS expressly understood that in all other respects, said terms and conditions of the agreement shall be in full force and effect.



BOND RESOLUTION OF THE TOWN OF ANDES, NEW YORK, AUTHORIZING THE ISSUANCE OF \$2,500,000 SERIAL BONDS TO FINANCE CONSTRUCTION, RECONSTRUCTION AND IMPROVEMENT OF THE TOWN SEWER SYSTEM

BE IT RESOLVED by the Town Board of the Town of Andes, Delaware County, New York as follows:

Section 1. The Town of Andes, New York (the "Town") hereby approves the construction, reconstruction and improvement of the Town sewer system, including reconstruction of the Town wastewater treatment plant, including purification or disposal plants or buildings, the acquisition of land or rights in land and original furnishings, equipment, machinery or apparatus required at an estimated maximum cost of \$2,500,000.

Section 2. It is hereby determined that the maximum estimated cost of the aforesaid specific object or purpose to be financed by the Town is \$2,500,000, said amount is hereby appropriated therefor and the plan for the financing thereof shall be the issuance of not to exceed \$2,500,000 serial bonds (the "Bonds") or bond anticipation notes of the Town which are hereby authorized to be issued pursuant to this resolution and the provisions of the Local Finance Law.

Section 3. It is hereby determined that the periods of probable usefulness of the aforesaid specific object or purpose is forty (40) years pursuant to subparagraph 4 of Section 11.00(a) of the Local Finance Law. The proposed maturity of the Bonds will be in excess of five years.

Section 4. Pursuant to Section 107.00(d)(3)(1) of the Local Finance Law, current funds are not required to be provided prior to issuance of the Bonds or any bond anticipation notes issued in anticipation of issuance of the Bonds.

Section 5. The temporary use of available funds of the Town, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Local Finance Law, for the capital purposes described in Section 1 of this resolution.

Section 6. The Bonds and any bond anticipation notes issued in anticipation of the Bonds, shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Bonds, and any bond anticipation notes issued in anticipation of the Bonds, shall be general obligations of the Town, payable as to both principal and interest by a general tax upon all the real property within the Town without legal or constitutional limitation as to rate or amount. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year.

Section 7. Subject to the provisions of this resolution and of the Local Finance Law, and pursuant to the provisions of Sections 21.00, 30.00, 50.00 and 56.00 to 63.00 inclusive of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the Bonds herein authorized, including renewals of such notes, and the power to prescribe the terms, form and contents of the Bonds, and any bond anticipation notes, and the power to sell and deliver the Bonds and any bond anticipation notes issued in anticipation of the issuance of the Bonds, and the power to sell and deliver the Bonds and any bond anticipation notes providing for substantially level or declining annual debt service, is hereby delegated to the Town Supervisor, the chief fiscal officer of the Town.

Section 8. The reasonably expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the Town's General Fund. It is intended that the Town shall then reimburse such expenditures with the proceeds of the Bonds and bond anticipation notes authorized by this resolution and that the interest payable on the Bonds and any bond anticipation notes issued in anticipation of the Bonds shall be excludable from gross income for federal income tax purposes. This resolution is intended to constitute the declaration of the Town's "official intent" to reimburse the expenditures authorized by this resolution with the proceeds of the Bonds and bond anticipation notes authorized herein, as required by Treasury Regulation Section 1.150-2.

Section 9. The serial bonds and bond anticipation notes authorized to be issued by this resolution are hereby authorized to be consolidated, at the option of the Town Supervisor, the chief fiscal officer, with the serial bonds and bond anticipation notes authorized by other bond resolutions previously or heretofore adopted by the Town Board for purposes of sale in to one or more bond or note issues aggregating an amount not to exceed the amount authorized in such resolutions. All maters regarding the sale of the bonds, including the dated date of the bonds, the consolidation of the serial bonds and the bond anticipation notes with other issues of the Town and the serial maturities of the bonds are hereby delegated to the Town Supervisor, the chief fiscal officer of the Town.

Section 10. Any federal or New York State grant funds obtained by the Town for the capital purpose described in Section 1 of this resolution shall be applied to pay the principal of and interest on the Bonds or any bond anticipation notes issued in anticipation of the Bonds or to the extent obligations shall not had been issued under this resolution, to reduce the maximum amount to be borrowed for such capital purpose.

Section 11. The Supervisor, as chief fiscal officer of the Town is hereby authorized to file an application with the New York State Comptroller pursuant to Section 124.10 of the Local Finance Law to exclude the proposed indebtedness authorized herein from the constitutional and statutory debt limits of the Town.

Section 12. The Supervisor is further authorized to sell all or a portion of the Bonds to the New York State Environmental Facilities Corporation (the "EFC") in the form prescribed in one or more loan agreements (the "Loan Agreements") between the Town and the EFC; to execute and deliver on behalf of the Town one or more Loan Agreements, Project Financing Agreements, and Letters of Intent with the EFC and to accept the definitive terms of

- one or more Loan Agreements from EFC by executing and delivering one or more Terms Certificates; and to execute such other documents, and take such other actions, as are necessary or appropriate to obtain a loan or loans from the EFC for all or a portion of the costs of the expenditures authorized by this Bond Resolution, and perform the Town's obligations under its Bonds or bond anticipation notes delivered to the EFC, the Project Financing Agreements and the Loan Agreements.
  - Section 13. The validity of the Bonds authorized by this resolution and of any bond anticipation notes issued in anticipation of the Bonds may be contested only if
  - (a) such obligations are authorized for an object or purpose for which the Town is not authorized to expend money; or
  - (b) the provisions of law which should be complied with at the date of the publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

- (c) such obligations are authorized in violation of the provisions of the Constitution.
- Section 14. This resolution, or a summary thereof, shall be published in the official newspapers of the Town for such purpose, together with a notice of the Clerk of the Town in substantially the form provided in Section 81.00 of the Local Finance Law.
- Section 15. This resolution is subject to permissive referendum pursuant to Article 7 of the Town Law of the State of New York. The Town Clerk is hereby authorized and directed to within ten (10) days after the adoption of this resolution by the Town Board to post and publish a notice in the manner and form prescribed by Article 7 of the Town Law.
- Section 16. The Town Supervisor, as chief fiscal officer of the Town, is hereby authorized to enter into an undertaking for the benefit of the holders of the Bonds from time to time, and any bond anticipation notes issued in anticipation of the sale of the Bonds, requiring the Town to provide secondary market disclosure as required by Securities and Exchange Commission Rule 15c2-12.

Section 17. The Town Board hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this resolution
