Highway Report April 9, 2018

After a rough march we are recovering from a very expensive group of nor'easter these storms cost the highway dept approximately 20,000 in repairs towing material and over time.

All but one truck is up and going again with the 5500 out of commission due to engine problems again

With less than 12,000 miles since its last new engine, it appears to be coolant loss through the engine

Talking with Young motors I've set up a appointment to have it looked at and I've been in contact with dodge customer care on warranty coverage appointment date is April 26

I've been contacted by O'brian and Gar they work for DEC they will be checking old landfills, we will be checking the one on old Gladstone hollow April 18 at 9am

With spring here we will begin tree clean up and what road repairs that we are able to do, sweeping of roads will also be taking place.

We have two new hires Jason Brandenburg, Ernst Bilzer both men have prior experience with townships

He reported that there is no Soils & Water funding at this time for streambank stabilization projects, however there should be in the future. He asked Bouton to keep track of any projects that will need to be done. He also asked Bouton to pick up a school bus sign up on Gladstone Hollow that has been run over.

*Discussed the purchase of the used dump truck from the Town of Colchester. They want \$125,000 for the truck and sander. It is very clean. John Bouton and Roger Robson both test drove it. The Town of Colchester is in a rotation where they purchase a new truck every year; that is why they are selling. They paid \$170,000 for it 5 years ago.

*Also discussed the trade of a tractor/mower for the screening plant with some type of shared services agreement.

*Lower Main Street was discussed. Supervisor Gladstone will be looking for funding a storm water grant to repair this.

Yes, the total unexpired life cost to change out 57 cobrahead streetlights would be \$2385.79. The New York State Department of Transportation (NYSDOT) is providing notice of the above referenced culvert project. The project proposes to replace deficient culverts on their existing alignment at various locations in the counties of Broome, Chenango, Delaware and Sullivan. These culverts are at the end of their service lives. While they show signs of major deterioration they are safe to cross. The objective of this project is to restore these culverts to condition ratings of "5" or greater, for at least 70 years, using effective techniques to minimize the cost of maintenance and repair over their service life. This letter pertains to all culvert locations except for culvert #C963069 (Site F) located on State Route 30 just outside of the village of Margaretville, which is being addressed separately. Maps are included to show the culvert locations.

Site A is on State Route 369 in the Town of Fenton, Broome County; Site B is on State Route 206 in the Town of Bainbridge, Chenango County; Site C is on State Route 206 in the Town of Masonville, Delaware County and Site G is on State Route 52 in the Town of Delaware in Sullivan County. The proposed work zone traffic control planned for these sites is staged construction. Staged construction is where traffic is maintained on one side of the existing structure while the opposite side is being constructed utilizing one-way alternating traffic controlled by temporary traffic signals. Once the first side is completed, traffic is placed on the newly completed side while the opposite side is reconstructed.


Site D is on State Route 28 in the Town of Middletown and Site E is on State Route 28 in the Town of Andes, both in Delaware County. The proposed work zone traffic control planned for these sites are an on-site diversion. An on-site diversion is where a temporary road and stream crossing are constructed on one side of the existing structure to provide for traffic during the reconstruction of the culvert. This too will utilize one-way alternating traffic controlled by temporary traffic signals.

In either case, properties with driveways that will be situated between the temporary traffic signals will need pushbuttons installed to safely enter the highway from their property. When the pushbutton is activated, it will cause a "red" condition at both traffic signals, which will stop traffic in either direction and allow for the vehicle to safely enter the highway and proceed in either direction.

The project is scheduled for bid opening in the spring of 2018 with construction to begin in 2018. It is anticipated that construction will take two years to complete all seven culverts in this project. Therefore, culvert work at these sites could take place in either 2018 or 2019.

The Department would appreciate your comments or concerns regarding this proposed project. Additionally, public comment is encouraged to identify any other transportation problems in the project area. NYSDOT seeks input on a continuous basis for planning improvements for all modes of transportation.
