#### Dear Town Council Members:

This correspondence is designed to inform you of a new component of NYCDEP Land Acquisition Program (LAP) titled the Streamside Acquisition Program (SAP). This program is focused on the acquisition of riparian buffers and parcels with significant surface water criteria.

SAP was initiated as a pilot program in the Schoharie Basin and administered through the Catskill Center for Conservation & Development for the past three years. SAP is expected to be expanded to all towns in the West of Hudson Watershed and could have a substantial impact on villages and hamlets. The following issues are of concern to the Delaware County Planning and Watershed Affairs Department.

- Municipalities will have the choice to "Opt-in" to the program. If the villages, hamlets choose to
  participate, the minimum parcel size will be waived for acquisition. Parcels less than ten acres
  will be open to solicitation by NYCDEP, parcels this small are currently not available for purchase
  by NYCDEP in the core LAP.
- The potential exists for the target parcels to be subdivided, this will require a resolution by the
  towns to accept sub-standard or non-compliant parcels. Each community will have to determine
  based on their comprehensive plans, zoning scheme and other relevant considerations, if this is
  in the public's best interest.
- All parcels purchased in fee through SAP will have a NYSDEC easement placed on them in perpetuity. The easement language could preclude or at least create impediments for future flood mitigation work and infrastructure installation.
- Preliminary investigations have shown that a significant portion of parcels in each hamlet or village have the surface water criteria needed to meet the SAP requirements, in most hamlets, nearly half the parcels could qualify.

The Delaware County Planning and Watershed Affairs Department wants to keep the towns informed during this period leading up to the adoption of the next NYSDEC Water Supply Permit. #### County Chamber Urges Local Officials to Allow Retail Cannabis Sales

The Delaware County Chamber of Commerce urges towns and villages to not "opt-out" of the opportunity to allow cannabis-related businesses and capture much-needed tax revenue. The Chamber seeks opportunities to sustain and grow our economy. Beyond retail opportunities, cannabis sales will allow our distressed farmers to tap into this multi-billion dollar industry, through cultivation as well as sales.

The Chamber supports legal cannabis sales for the following reasons:

- The Chamber supports all legal businesses
- Total market demand for legal adult-use cannabis in New York is about \$3.7 billion in the current fiscal year [Marijuana Legalization in New York State--A Fresh Look by James Parrott and Michele Mattingly], with demand rising to \$3.9 billion by FY 2027. However, because legal sales would grow over time and gain market share at the expense of illicit sales, legal market sales would rise from \$566 million in the first full fiscal year of implementation (FY 2023) to \$2.6 billion four years later (FY 2027).
- Using these estimates, State excise tax revenue would be \$159 million in FY 2023, rising to \$765 million in FY 2027. Local share of the excise tax would generate \$25 million, statewide, in FY 2023, rising to \$114 million in FY 2027.
- The Parrott/Mattingly report used a model to reflect 100% in-state cultivation and processing of all cannabis to estimate that the \$2.6 billion in retail sales projected for FY 2027 would generate 50,860 jobs, \$2.2 billion in employee compensation, \$4.7 billion in value added, and \$6.1 billion in total economic output. In addition to the sales-related tax revenues projected above, the expansion of an entire economic sector in New York State will generate additional state and local tax revenue.
- Delaware County farmers, retail owners, residents, and visitors will lose if surrounding towns and counties allow cannabis businesses. Tourists will flock to cannabis-friendly communities and residents will simply buy products elsewhere, depriving Delaware County of those tax revenues.

The public policy question of whether cannabis should be legal is not relevant to the issue of allowing adult-use retail sales and cultivation facilities to operate in Delaware County communities. Adult-use cannabis legislation was passed by the NYS Legislature and signed by the Governor in March 2021. Disagreement with the law should be taken up with our state representatives and regulators, and not town supervisors and mayors. Instead, the Chamber urges local officials to support legal businesses and allow retail cannabis sales.

Dear All Listed Above:

As a proud Andes resident for over 30 years, I am compelled to write to you regarding issues that I believe need your immediate attention.

1. On the night of August 14, 2021, Andes Community Day, there was an extensive fireworks display for the public in the back of the Andes Hotel, conducted on private property, without permission. It is my understanding that the people who planned and/or managed Andes Community Day hired and paid for the person who conducted the display, with many people attending, and the crowd was not Covid-19 managed. I have photographs of the event.

The owner of the property is Andreas Gerdes. As he is out of the country, I am his appointed representative in Andes. Andreas indicated to me that no one contacted him, nor did they contact me to obtain permission to conduct the display of fireworks. We did not receive any information regarding a plan, a permit, liability insurance, a covid management plan, or any other documentation of approval of the activity. This is a reckless, irresponsible action, a violation of personal property, and is legally actionable.

It is also my understanding that there is another event planned by Stars and Stripes on September 11, 2021, whereupon another fireworks display is featured, to be held at the same place, behind the hotel on Andreas' private property. How and why do people assume that it is acceptable to use someone else's personal property for fireworks displays, or any other use, as no one has contacted me nor Andreas for permission?

Fireworks are extremely dangerous and must be conducted by professional, experienced people. If not handled properly, fires, injuries, destruction of property abound, which is why liability insurance is a must, yet there was none on 8/14/2021. Also, it encourages a crowd situation; amid a covid uprising in Andes, how is this acceptable? What covid management plan will be in place for the upcoming Starts and Stripes event? If a lawsuit ensues due to mismanagement of fireworks, covid exposure, destruction of property, and/or a host of other issues, Andreas Gerdes and the Town of Andes are at risk for legal ramifications. I trust that you do not want to see anything of that nature occur and am hopeful you will contact the Stars and Stripes Committee, as well as the people who hired the fireworks display company on 8/14/21 and advise them that they need to protect the property owner, themselves, and the Town of Andes legally, and follow the appropriate steps when organizing these events.

We are specifically demanding that the organizers who wish to use the property behind the hotel that belongs to Andreas, or any other properties owned by Andreas, must provide a written plan of what they intend to do on the property, how it will be used, including time and date details, quantity of people, provide liability insurance listing him and his representatives additionally insured, and provide a covid management plan, including how they plan to enforce it. This all must be in writing, pre-approved prior to any events.

- 2. The second issue to address involves the business Willbees, at the corner of Main Street and Delaware Avenue (the former "Cantina" building.) As I said at the opening of this letter, I have lived in Andes for over 30 years, and raised my children here. I now have three young grandchildren, two age 10 and one age 8, who visit on a regular basis. Twice now they have encountered very disturbing, unacceptable situations at Willbees, as follows:
- a. A few weeks ago, my grandchildren were playing on the sidewalk near Willbees with their scooters. They noticed in the window of Willbees prominently displayed male genital "sculptures." One of the kids (not my grandchildren, but he was with my grandchildren) asked the owner how the sculptures are made, and the owner proceeded to show him in the presence of all of the children there, exactly how to make a "male genital mold" of their own "personal private parts." My grandchildren relayed the conversation to me. I remain shocked, disgusted and worried that this is happening in our town.
- b. On Andes Community Day, this year, there were chalk drawings of male genitals on the Andes town sidewalk, as "arrows" pointing to the entrance of Willbees. Attached are photographs. I know for a fact that this is not the first complaint about these drawings, because photos were sent to our Supervisor, and other parents have complained to me, as well. As you know, many families walk in the area to and from the pool. Another friend said they went into the store to buy retro furniture, and found themselves surrounded by "penis art." They were so uncomfortable, they walked out and encountered a family about to enter and said, "don't bring your children in there."

I am horrified that these two incidents occurred with my grandchildren and wonder what the hell is happening in Andes. Is it losing its small-town benefits? I now am worried about my grandchildren playing in the Hamlet of Andes. *Are they safe?!* When my children grew up here in Andes, they knew the corner building as the General Store, then Dave & Bernies, then the Cantina. Now my grandchildren know that building as "the penis store." This is all very distressing and disappointing.

When the Planning Board approved the Willbees business, did they examine the nature of the business? If they did and approved it, why? If they did not, why not? Isn't that the purpose of the Planning Board and the Town Board, to protect and ensure the safety of the Town and its residents? All of you manage and control the Town and Hamlet of Andes, and all I see lately is a town, that used to be a wholesome and safe place to live and raise your children, turn into a unsafe, anything goes environment. I find this extremely alarming and demand answers as to why this is being allowed.

The issues outlined in this letter are not to be ignored. I look forward to hearing from you. Thank you for your prompt attention.

#### **AGREEMENT**

## BETWEEN THE TOWN OF ANDES, NEW YORK

# AND CEDARWOOD ENVIRONMENTAL SERVICES (DELAWARE OPERATIONS INC.)

### FOR SERVICES AS A CONTRACT WATER TREATMENT PLANT OPERATOR

THIS AGREEMENT made the <u>23th</u> day of <u>August</u>, <u>2021</u> by and between the TOWN OF ANDES, NEW YORK, located at the Town Hall, Andes, New York 13737, (herein referred to as the Owner), and Cedarwood Environmental Services, having a place of business at 464 Main Street, Oneonta, New York 13820, (herein referred to as the Operator).

#### WITNESSETH:

WHEREAS, the Owner is desirous to contract for the operation of their Water Treatment Plant, and to maintain professional administration of the same facility for a period of Three (3) years,

**AND WHEREAS**, the Owner is desirous of entering into an agreement for the purchase of services for Operator and engineer to complete the agreed upon tasks as they relate to the operation of the Andes Water Treatment Plant for a period of Three (3) years,

**AND WHEREAS**, the Operator has submitted a proposal to the Owner for contract operation, for engineering support services, supervision, and general administration, the Owner now desires to enter into an agreement.

# THEREFORE, the Town and Operator do mutually agree as follows:

- (1) The Operator shall provide the following services to the Town, subject to modification at any time by the Town:
  - a. Daily inspection of the Water Plant and all required daily testing.
  - b. Routine sampling required by the NYS Department of Health.
  - c. Filing of monthly reports to the NYS Department of Health.
  - d. Handle any inspections by the NYS Department of Health.
  - e. Write any needed correspondence, pertaining to daily operation, to the NYS Department of Health and explain any correspondence received.
  - f. Annual flushing of hydrants on the system.
  - g. Operation of Well when needed.
  - h. Monthly cleaning of chlorination equipment.
  - i. Technicians Services \$80 per hour\*.

    Technicians would be available to help in repairs to the system, gather information needed for mapping of the water system, location of valves and



lines, development of preventative maintenance programs, corrosion control development and implementation, installation of metering equipment, and other work outside the scope of daily operations.

j. The Operator will receive prior approval from the Owner for any operational expense that exceeds \$500 unless required in an emergency situation. In an emergency situation, the Operator shall notify the Owner as soon as possible of the circumstances of the emergency.

k. Engineering Services - \$150 per hour.

These services would include submittals to the NYS Department of Health that require the stamp of a licensed Professional Engineer.

1. Should the Operator be required to provide services beyond the abovementioned services those services shall be provided only with prior authorization from the Owner and shall be billed at the following rates:

Engineering (not related to Operations)	\$150.00 per hour
Corporate Management	\$130.00 per hour
Operations	\$95.00 per hour
Mechanic	\$85.00 per hour*
Laborer	\$75.00 per hour*

\*If work is completed under the New York State Prevailing Wage Law, the hourly rate will be the current prevailing wage schedule for the locality where the work is performed.

(2) The Town agrees to provide the following in conjunction with operation of the water system:

SNOW REMOVAL
ALL EXCAVATION WORK
CHEMICALS
MATERIAL AND SUPPLIES
PLANT INSURANCE
UTILITIES
CAPITAL IMPROVEMENTS
SPECIALIZED MAINTENANCE CONTRACTS
LAB SUPPLIES

(3) The Town shall pay to the Operator, for the above-described services, a monthly sum of: for contract year 2022 - One Thousand Two hundred and Eighty-Two dollars (\$1,282.00), for contract year 2023 - One Thousand Three hundred and Fourteen dollars (\$1,314.00) and for contract year 2024 - One Thousand Three Hundred and Forty-Seven dollars (\$1,347.00) for year three of this contract.

BILLING FOR PERSONNEL SERVICES WILL BE DONE ON A MONTHLY BASIS AT THE ABOVE RATES.



CONTRACT DURATION TO RUN FROM JANUARY 1, 2022 THROUGH DECEMBER 31, 2024. PAYMENTS ARE DUE TO THE OPERATOR WITHIN THIRTY (30) DAYS OF INVOICE DATE.

#### (4) TERMINATION:

- a. This agreement may be terminated in whole or in part in writing by the Owner and/or Operator for its convenience, provided that the other party is given (1) not less than sixty (60) calendar days written notice (delivered by certified mail, return receipt requested) of intent to terminate and (2) an opportunity for consultation with the terminating party prior to termination.
- b. If this agreement is terminated by the Owner based upon the improper actions of the Operator, an equitable adjustment in the price provided for compensation in this agreement shall be made for work actually performed hereunder, but (1) no amount shall be allowed for anticipated profit on unperformed services or other work, and (2) any payment due to the Operator at the time of termination may be adjusted to cover any additional costs to the recipient because of the Operator's default.
- c. If this agreement is terminated by the Operator based upon the improper actions of the Owner, any equitable adjustment shall include a reasonable profit for services or other work performed to date. The equitable adjustment for such a termination shall provide for payment to the Operator for services rendered and expenses incurred prior to the termination.
- Upon Notice of Termination by either Owner or the Operator, the Operator shall d. be obliged to continue to operate the Treatment Facility for a period not to exceed two (2) months from the date of the Notice if so desired by the Owner. During this period, the Operator shall work with an Owner's representative. designated contractor, and/or employee to familiarize them with the treatment processes. Operator shall oversee the operation of the Facility, with During this period, the Owner's designated representative, contractor, and/or employee in a trainee position. The Operator will remain responsible for the efficient operation of the unauthorized changes processes. The Operator will not be responsible for any in the treatment processes by Owner's designated contractor, representative, and/or employee.
- (5) **REMEDIES.** Except as may be otherwise provided in this Agreement, claims, counterclaims, disputes, and other matters in question between Owner and the Operator arising out of or relating to this Agreement or the breach thereof will be decided by arbitration if the parties mutually agree, or in a court of competent jurisdiction within the State in which Owner is located. The parties agree that Delaware County will be the proper venue for any such litigation or arbitration.



- (6) **INSURANCE.** The Operator shall obtain and maintain during the life of this contract, at this own expense, such Worker's Compensation, Public Liability and Professional Liability insurance as will adequately protect the Operator from claims which may arise or result from the Operator's performance or by anyone employed by him. Upon request from the Owner, the Operator shall provide a Certificate of Insurance attesting to the requisite coverage and limits.
- (7) The Owner agrees to indemnify and hold harmless the Operator, its officers, employees, or agents, for any liability for damages or claims for personal injury including death, property damage caused by blockage, ruptures, effluent discharges, release or escape of materials to air, land, or water, which are beyond control of or were not caused by the sole negligence of the Operator, its officers, employees, or agents.
- (8) The Operator acknowledges that it is an independent contractor and not Owner's employee in connection with the work undertaken by the Operator in the Agreement. The Operator alone is responsible for any loss or damage caused by its subcontractors, agents, or employees, and will fully defend, indemnify, protect, and save harmless Owner against any and all loss, damage, expense, penalties and/or fines resulting from any and all claims and liabilities arising from the operation of the wastewater treatment facility by the Operator and its subcontractors, agents, or employees, during the performance of this Agreement or any Agreement between Owner and the Operator for extra work. The Operator will accept no financial liability including fine and/or penalties resulting from Owner's failure to approve requested work.
