Community Notice: Noise Control Request

The town board has received numerous complaints about excess noise from local taverns. We understand that music, karaoke, events, and large gatherings are essential for your business and contribute to other businesses. However, we request that you respect the residences in Andes by adhering to an agreeable time frame to cease loud sounds and noise levels from music or large group assemblies.

The state noise statutes prohibit unreasonable noise levels in all communities. We request that all unreasonable noise cease from 10 p.m. to 7 a.m. on weekdays and Sunday, and from 11 p.m. to 8 a.m. on Friday and Saturday. Because the law is hard to enforce, we ask that tavern owners and staff work with the community to control the noise at your establishments and abide by the times requested in this letter.
