### Call to Order:

Meeting Called to Order by Supervisor Gladstone at 7:00PM

**Pledge:** The pledge of allegiance was led and recited by Councilman Cole.

#### **Minutes:**

#### **Privilege of the Floor:**

Lisa Marasa suggested signs be available at the Clerk's office for residents to have on property to alleviate the issue of parking and dog waste. There are also several areas around town where people tend to illegally park. Notably the crosswalk in front of the diner due to it being in a dangerous location with blind spots. Suggestions to move the crosswalks were made. There is a possibility of meeting with the DOT to discuss moving the crosswalks. In addition, more handicap parking is needed in town as well as enforcement. The Fire Department should be alerted before events to direct traffic.

Supervisor Gladstone: We have had this issue for a long time and we need to be presented with a solution that works. There just isn't land available to use for a parking lot.

Jim Andrews: Suggested using the "Lilly Farm" near Ron Guichard's building in town for parking. This needs to be discussed with the land owners.

Kristina Zill: Andes has been approved for \$15000 NYSERDA Grant for clean energy. Currently we are using \$5000 of the grant money to improve the heat pump at the Andes Public Library. An option to use the rest of the funds could be to install a heat pump at the Andes Railroad Depot which is also used by the Andes Food Bank. It is decided that estimates will be obtained for the work.

Dede Shelton: Automated Speed Limit Signs update. There have been more incidences of speeding. Supervisor Gladstone has reached out to the O'Connor Foundation to get a grant for installing the speed signs. Other residents have also complained about the excessive speeding in town and the danger it poses to residents.

Karen Bornarth: Suggested a noise ordinance be enforced in Andes. There is excessive noise on all days of the week until very late hours. It is decided that Alfred Mohr can look into writing rules surrounding noise in Andes. It is pointed out that here is a lack of ways to enforce such rules.

### **New Business:**

Mary Peterson has requested that repairs be done to the RR Depot before winter. Supervisor Gladstone and Councilman Gabriel agreed to look at and assess the damages.

Anne Slevin has proposed that dog waste receptacles be placed in town. It is decided that an estimate needs to be presented of cost, maintenance and locations.

The wall above old Gladstone hollow failed along with the lower culvert destroyed the lower part of road. Beech hill had 2 major wall failures. I had Delbull dozing make repairs to them along with Felton lower sections and we repaired road above on Felton. We still have major damage on Lower Dingle hill road, Gamblicher, Doig Hollow. And minor damage on all other town roads. We are still waiting to hear whether or not this storm will be declared by Fema.
