#### Call to Order:

#### Minutes:

#### Privilege of the Floor:

Robert Abbate spoke about the potential for the town to purchase property on 74 Main Street to construct a parking lot. Mr. Abbate was concerned that the tax payers of Andes would be burdened with the cost of the project and the result would not be beneficial enough to justify the cost. Supervisor Gladstone added that the town was not obligated into a contract and the idea of purchase is only in the early stages. Mr. Abbate suggested that before the purchase of the property the town should have the land and structure examined for materials hazardous to the environment.

Eric Van Benschoten added that there might be other options for parking such as by the School or in back of Wayne Bank.

Cyndi Wright added that erecting meters in the new parking lot could be a solution for earning money back on the project.
